On March 16th, the President issued updated Coronavirus Guidance for America. This guidance states that:

"If you work in a critical infrastructure industry, as defined by the Department of Homeland Security, such as healthcare services and pharmaceutical and food supply, you have a special responsibility to maintain your normal work schedule."

On March 19th, the Cybersecurity and Infrastructure Security Agency (CISA) issued guidance on an initial list of "Essential Critical Infrastructure Workers." A full copy of the guidance memo may be found at this link:

CISA is clear that state and local government have primary responsibility to implement response activities in their communities and that this guidance is not intended to preempt or override those decisions. However, it is intended to inform and help ensure consistency as local governments implement their response plans.

A particular area of concern that has been discussed heavily since issuance of this guidance is ensuring that food and agricultural workers and shipments move freely in the event of local, state or federal shelter-in-place or other similar movement restrictions. *While nothing in this memo should be construed as legal advice,* we are providing a model letter that can be issued on your company's letterhead and provided to employees and drivers to inform them of this guidance and to assist them in the event of movement restrictions in your area.

Employee Travel Related to Critical Infrastructure
