Dear Secretary Perdue:

With the signature of the COVID relief package, USDA is now directed to distribute \$100 million in funds through the Specialty Crop Block Grant Program. The below organizations representing specialty crops from across the country would like to offer some recommendations to USDA and state departments of agriculture in terms of utilizing and prioritizing this supplemental funding.

As stated in the legislation, this funding is being provided "[d]ue to the impact of COVID-19 on specialty crops," This funding should be focused on COVID-19 related issues. To that end, <u>our top priority is to protect the health of our employees and the workforce</u>. And while the specialty crop industry has taken a number of important industry-driven actions related to this effort, additional funding to buttress these efforts comes at a critical time. Therefore, as we look at the addition of these new resources through the Specialty Crop Block Program, there are a number of priorities that come into focus:

- 1. Utilizing funding for workers' PPE against COVID, such as gloves, masks, hand sanitizer as well as touchless thermometers. Funding should be allowed for reimbursing those COVID PPE investments made since the onset of the pandemic in March 2020.
- 2. Funding should also be directed at COVID related infrastructure improvements that producers have made and will make to protect their workforce, such as the installation of plexiglass or other appropriate divides, and ventilation upgrades including reimbursing those improvements made since the onset of the pandemic in March 2020.
- 3. Funding should also be directed at offsetting costs related to COVID prevention measures within worker housing changes and transportation of the workers; including reimbursing those improvements made since the onset of the pandemic in March 2020.
- 4. As our nation prepares to undertake a massive vaccination program, our workforce faces unique challenges (i.e. language, culture and remote or rural worker populations). Funding should be utilized to help offset out-of-pocket expenses related to vaccination of farmworkers, packing and processing workers, and other specialty crop industry front-line employees. One element of vaccination will no doubt require a significant education and outreach campaign for employees and employers and that too should be eligible for funding.
- 5. Due to COVID-19 disruptions of market channels, funds should also be utilized to provide for product marketing and promotion of locally grown fruits and vegetables.

These are a few examples that we suggest be considered as this needed COVID-related funding is allocated to state department of agricultures and then to the specialty crop industry across the country. Finally, Congress intended, and we agree, that this funding should be thought of <u>as separate and</u> <u>distinct from the traditional specialty crop block grant funding</u> which is directed through the farm bill and covers broad specialty crop needs not related to the COVID pandemic.

Thank you for your consideration of this letter. We look forward to working with each of your teams in the process of implementing this important funding to specialty producers across the country.
